**HONORING RICHARD "DICK" OTTINGER**

(Mr. LATIMER asked and was given permission to address the House for 1 minute.)

Mr. LATIMER. Mr. Speaker, for nearly two decades, Westchester's own Richard "Dick" Ottinger walked in these Halls as a Congressman and served in this Chamber, representing his neighbors with insight and energy.

Dick Ottinger was first elected to the House in 1964. He left to seek a seat in the United States Senate in 1970 but returned here in 1974 to serve 10 more years. He was an early leader on environmental issues before they became commonplace, and his advocacy for the cleanup of the Hudson River benefited generations to follow.

In his post-congressional years, he turned to teaching as a professor at Pace University School of Law, with a building being named in his honor.

We lost Dick Ottinger on February 16, and he joins in our memories the great House Members from New York who we have recently lost, Charlie Rangel and Nita Lowey.

Dick, like them, is a role model for all of us who serve here today.

Please join me in a moment of silence to honor him.

**HONORING OUR FALLEN HEROES**

(Mr. NUNN of Iowa asked and was given permission to address the House for 1 minute.)

Mr. NUNN of Iowa. Mr. Speaker, I rise today to honor six Americans, including two Iowans, who gave their lives for our country.

On March 1, an Iranian drone struck a U.S. Army command center in Kuwait and killed six members of the 103rd Expeditionary Sustainment Command in the Army Reserve, which operates out of Fort Des Moines, Iowa, in my district.

I will speak first about these two young Hawkeyes. Sergeant Declan Coady of West Des Moines was only 20 years old. He was one of the youngest men in his unit and, by every account, one of the best.

Sergeant Coady trained as an IT specialist with the Army Reserves while studying cybersecurity at my alma mater, Drake University, right here in Des Moines. He was taking classes online from Kuwait while he defended our country in order to become an officer in the U.S. Army.

Last week, he proudly told his father that he had been recommended for promotion from specialist to sergeant. I am happy to say that he posthumously achieved that very honorable rank.

With him was Major Jeffrey O'Brien, 45, of Waukee and Indianola, Iowa, a senior officer in the same unit who spent decades in service. He gave his life keeping our forces in Kuwait safe and Americans at home guarded.

I will say the name of every one of our fallen because every family represented here today, amongst my colleagues from each State where they grew, lived, and served, deserves to be honored by this Nation in our moment of national heartbreak.

Captain Cody Khork, 35, of Winter Haven, Florida.

Sergeant First Class Noah Tietjens, 42, of Bellevue, Nebraska.

Chief Warrant Officer 3 Robert Marzan, 54, of Sacramento, California.

Out of grief, we renew our resolve. Out of loss, we strengthen our unity, and out of sacrifice, we carry forward an obligation to the families, to the survivors, to our Nation, and to every man and woman still standing the post today.

Mr. Speaker, I respectfully ask that the House now observe a moment of silence in honor of our fallen.

**CALLING OUT ANTI-SEMITISM**
