MOMENT OF SILENCE IN HONOR OF VICTIMS OF SHOOTING AT ISLAMIC CENTER OF SAN DIEGO

(Ms. JACOBS asked and was given permission to address the House for 1 minute.)

Ms. JACOBS. Mr. Speaker, I rise today with a heavy heart to honor the lives of Amin Abdullah, Mansour Kaziha, who went by Abulezz, and Nadir Awad who were murdered at the Islamic Center of San Diego on Mon-

day, a holy day in the final and most sacred month of the Islamic year.

I am heartbroken for their families, for all of the students who were scared for their lives and were evacuated out of the school hand in hand, and for the greater Muslim community in San Diego and across the country.

The Islamic Center is a special place for the Clairemont community, a sanctuary for peace, comfort, and safety. Unfortunately, that was ripped away from our community by two people armed with guns and hate.

This tragedy didn't happen in a vacuum. We let it happen by refusing to actually do something and stop the rise of Islamophobia and anti-Muslim hate and hatred of all kinds.

For decades, the Islamic Center has been the target of hate speech and vandalism and yelling by people driving by, so this is a very resilient community because they have had to be a resilient community, but this has to be where we draw the line. It has to be because I refuse to let Amin, Abulezz, and Nadir's sacrifices be in vain.

Amin worked as a security guard at the center for years. He came to work every day, prepared to protect his place of worship, and when confronted by the gunmen, he gave his life to save others.

Abulezz was the heart and soul of the mosque for nearly 40 years. He was a constant presence, a pillar of the community, and a beloved husband, grandfather, and father who treated every child at the mosque as his own. He died doing what he loved most in the world: caring for the children of the mosque.

Nadir was a devoted member of the Clairemont community who gave his life shielding others from the gunmen.

This tragedy could have been so much worse had it not been for all of their sacrifices. They had the courage and bravery to stand up in the face of danger, to distract, delay, and even engage with the gunmen to save others.

We owe it to them to prevent the next hate crime, the next attack on our Muslim community because this is an attack on all of us. It is an attack on everyone's right to gather, worship, learn, and live in peace and safety. It is an attack on pluralism, on our right to celebrate our differences and coexist. It is an attack on our entire community, and we won't tolerate it.

To our Muslim community, we are here for you. We mourn alongside you. We will honor the lives of these great men we lost by coming together and showing that our response to hate is love. It is compassion. It is understanding. It is community.

Mr. Speaker, I ask all of us to join in a moment of silence in honor of Amin Abdullah, Abulezz Kaziha, and Nadir Awad.

RECOGNIZING CINDY HAHN

PRESIDENT TRUMP'S BIG, BEAUTIFUL BALLROOM

Mr. LATIMER. Mr. Speaker, I rise today to express our collective national dismay over the President's big, beautiful ballroom.

While Americans struggle daily with ever-increasing bills for food, gasoline, and utilities, President Trump dishes billions in payouts to Capitol rioters and no-bid contracts on vanity projects: fountains, reflecting pools, a triumphal arch, the Kennedy Center, and, most infamous of all, the White House ballroom, a monstrous homage to the age of Emperor Nero.

Unsurprisingly, we now find the ballroom will cost American taxpayers \$1 billion for the benefit of one man.

I ask myself: How can Americans be expected to keep funding the lifestyles when prices for necessities continue to climb?

Mr. Speaker, on behalf of the constituents of New York, we say: Enough.

I encourage my colleagues to take this sentiment to heart and reject the latest appropriation request. This is clearly the wrong priority at the wrong time.

SECOND AMENDMENT RIGHTS

(Ms. BOEBERT asked and was given permission to address the House for 1 minute and to revise and extend her remarks.)

Ms. BOEBERT. Mr. Speaker, this week marks the 40th anniversary of the Hughes amendment which is a stark reminder of how Congress has repeatedly infringed upon the Second Amendment rights of law-abiding citizens.

Today, I introduced the Freedom From Taxes Act. This important legislation fully repeals the remaining excise taxes on machine guns and destructive devices under the National Firearms Act and eliminates the special occupational tax on Federal firearms licenses.

Building on the strong progress we achieved in the One Big Beautiful Bill Act, this legislation completely zeros out the final NFA taxes, reducing the annual burden from \$1,000 to \$0 for importers and manufacturers, and from \$500 to \$0 for dealers.

It also ends the burdensome special occupational tax that has been weighing down small businesses and manufacturers across America's firearms industries for far too long.

I want to thank the Gun Owners of America and the National Rifle Association for supporting this bill and defending our always under-siege Second Amendment.

The government has no business penalizing law-abiding citizens who are simply exercising their God-given Second Amendment rights. By removing these unfair taxes, we are providing meaningful relief to hardworking gun owners, hardworking manufacturers, and small businesses that form this industry.

CHAMPION OF THE WEEK: AKRON MENTAL HEALTH COURT

Mrs. SYKES. Mr. Speaker, May is Mental Health Awareness Month, a time for us to stop and consider how mental health impacts and effects everyone in our communities. For that reason, I am going to recognize the Akron Municipal Mental Health Court as Ohio's 13th Congressional District's Champion of the Week.

This week, the court is celebrating its 25th anniversary. Founded by Judge Elinore Marsh Stormer in response to the growing number of people with serious mental illnesses entering into the criminal justice system, the Akron Municipal Mental Health Court became the first of its kind in Ohio, and one of the first in the Nation.
