Never afraid to speak his mind, he was an effective legislator who understood the importance of principled negotiation and the reality that lasting progress often requires both conviction and compromise. He was not afraid of holding his convictions, and he was not afraid of a compromise when he could declare victory. In times of great challenge, his quick wit and keen sense of humor served him well in his work, providing a much-needed sense of levity.

There are many stories that JIM MCGOVERN and I spoke of that we can never tell publicly, but he had a great piece of advice for all Members of Congress because Members of Congress tend to say: Let's have another study. Barney said: Anytime a Member of Congress asks for a study, they should be required to pass a written test within 6 months of their study.

For those of us in the delegation, we had the privilege of calling him many things—colleague, mentor, confidant—but it was an even greater privilege to call him a friend. Massachusetts and the Nation are better off because of our friend, Barney Frank.

To Jim Ready and his family, we want to wish our best at this very difficult time. We have lost a giant of legislative life and a very loyal member of this institution and a very important alum.

I ask that the Chamber now rise to join us in a moment of silence in memory of Chairman and Congressman Barney Frank.

Mr. NEAL. Mr. Speaker, I rise today with our colleagues from Massachusetts to pay tribute to the late Congressman and Chairman Barney Frank, who passed away 2 days ago at the age of 86.

I spoke with Barney recently, and I asked him how he was doing. He said he was going blind, he couldn't walk, and his heart was failing, but other than that, he was on top of his game.

He faithfully served the people of Massachusetts in the Fourth Congressional District for more than three decades, and his constituents could not have asked for a stronger voice representing them in this House.

He was a competent legislator, from time to time an irascible personality, always a man of good wit and humor, and a superb legislator. He would perhaps put that at the top.

His legislative achievements were too numerous to list. He was a trailblazer for the gay community, a champion of civil rights, and a fierce advocate for expanding access to affordable housing and economic opportunities for America's working families.

As chairman of the Financial Services Committee, Barney ushered in change during one of the most tumultuous periods in our history. Also, as a piece of advice for Members of this Chamber, he mastered the most arcane details of complicated policy. It was not about just using your thumbs, it was about convincing people of the merit of your argument.

When you look at Dodd-Frank, it was praised widely by Republicans and Democrats across the financial com-

VOTING RIGHTS MUST BE PROTECTED

(Ms. DEAN of Pennsylvania asked and was given permission to address the House for 1 minute and to revise and extend her remarks.)

Ms. DEAN of Pennsylvania. Mr. Speaker, Tuesday was primary day in Pennsylvania. It was a safe, successful election where thousands of voters made their voices and their vote known.

Yet, it was a dark reminder that voting rights across the country are under attack. On April 29, the Supreme Court of the United States gutted the Voting Rights Act, opening the door to coordinated attacks on Black voters, particularly in the South.

Emboldened by the Court, Republican Governors and legislatures immediately moved to redraw congressional maps in their favor by dismantling majority-Black districts. Not since Jim Crow have we witnessed such a blatant and disgusting effort to disenfranchise Black voters.

I had the privilege, many of us had the privilege of serving alongside the Honorable John Robert Lewis. In times like these, I am reminded of his words. He would say: "When you see something that is not right, that is not fair, not just, you have to speak up. You have to say something; you have to do something."

Voting is our sacred right. It is the lifeblood of our democracy. Every one of us must protect it. We must do something before it is too late.

HONORING DANIEL G. WUCHTER

RECOGNIZING RABBI JON CUTLER

On behalf of Pennsylvania's Sixth District, I thank Rabbi Cutler for his extraordinary service to both our Nation and our community, and I wish him and his family all the best in his retirement.

AMERICAN DREAM OF HOMEOWNERSHIP

(Mr. NUNN of Iowa asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. NUNN of Iowa. Mr. Speaker, together, in a bipartisan fashion, this Chamber passed the 21st Century ROAD to Housing Act, the most significant update to rural housing programs in decades.

I fought to make sure my Rural Housing Service Reform Act was front and center in this package, because in rural Iowa, the Federal programs meant to help families buy, repair, or keep their homes are running on technology that is almost as old as the internet itself. Families are paying the price.

Iowa families are waiting, in some cases up to a year, for a U.S. Department of Agriculture's housing loan while interest rates change and prices
