Also, a memorial of the Senate of the Commonwealth of Kentucky, relative to Senate Resolution No. 189, expressing support for the Ohio River Restoration Program Act to advance clean water, economic development, community stability, and expanded recreation opportunities in the Commonwealth of Kentucky; which was referred to the Committee on Transportation and Infrastructure.
