

PUBLIC BILLS AND RESOLUTIONS

Under clause 2 of rule XII, public bills and resolutions of the following titles were introduced and severally referred, as follows:

By Mr. LANGWORTHY (for himself and Ms. SCHRIER):

H.R. 9661. A bill to amend the Public Health Service Act to codify that the default expectation for licensure of biological products as biosimilar does not include clinical studies assessing pharmacodynamics or comparative clinical efficacy, and for other purposes; to the Committee on Energy and Commerce.

By Mr. STEUBE (for himself, Mrs. BICE, Mr. NORMAN, and Mr. BURCHETT):

H.R. 9662. A bill to amend the Immigration and Nationality Act to impose limits on birthright citizenship for aliens and illegal migrants; to the Committee on the Judiciary.

By Mr. BAIRD:

H.R. 9663. A bill to amend the Environmental Research, Development, and Demonstration Authorization Act of 1978 to establish in the Environmental Protection Agency the State Standing Committee, and for other purposes; to the Committee on Science, Space, and Technology.

By Mr. VAN ORDEN:

H.R. 9664. A bill to require the establishment of a grant program to assist with certain veterinary expenses of retired Federal working dogs, and for other purposes; to the Committee on Oversight and Government Reform.

By Mr. VAN ORDEN:

H.R. 9665. A bill to amend title 38, United States Code, to expand the jurisdiction of Department of Veterans Affairs police officers, and for other purposes; to the Committee on Veterans' Affairs.

By Mr. CISCOMANI (for himself and Mr. PAPPAS):

H.R. 9666. A bill to direct the Secretary of Veterans Affairs to establish a pilot program to use four-dimensional functional lung imaging software product to identify respiratory disorders and lung disease in veterans, and for other purposes; to the Committee on Veterans' Affairs.

By Mr. FULLER (for himself, Mr. CARTER of Georgia, and Mr. McCORMICK):

H.R. 9667. A bill to amend the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 to restrict eligibility for Federal welfare programs to citizens of the United States, and for other purposes; to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, Financial Services, Education and Workforce, and Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. DAVIS of North Carolina (for himself and Mr. NUNN of Iowa):

H.R. 9668. A bill to authorize financial institutions to delay or refuse transactions that may involve the financial exploitation of older adults and vulnerable persons, and for other purposes; to the Committee on Financial Services.

By Ms. ADAMS (for herself, Ms. CLARKE of New York, and Mr. CARSON):

H.R. 9669. A bill to direct the Secretary of Health and Human Services, acting through the Assistant Secretary for Mental Health and Substance Use, to establish a 5-year pilot program under which the Secretary will award grants to eligible entities for purposes of expanding forensic assertive com-

munity treatment team programs; to the Committee on Energy and Commerce.

By Mr. COHEN (for himself and Mr. CARSON):

H.R. 9670. A bill to amend title 11, United States Code, to provide bankruptcy protections for medically distressed debtors, and for other purposes; to the Committee on the Judiciary, and in addition to the Committee on Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mrs. DINGELL (for herself, Ms. CLARKE of New York, Ms. NORTON, Ms. WILSON of Florida, and Ms. TLAB):

H.R. 9671. A bill to expand access for workers experiencing symptoms related to menopause and the menopause transition to reasonable accommodations that enable them to perform the essential functions of their job without risking their health or economic security; to the Committee on Education and Workforce, and in addition to the Committees on House Administration, Oversight and Government Reform, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. DOGGETT (for himself and Mr. SMUCKER):

H.R. 9672. A bill to amend the Public Health Service Act to make updates to the Vaccine Injury Compensation Program, and for other purposes; to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. EZELL (for himself, Mr. PANNETTA, Ms. TOKUDA, and Ms. PINGREE):

H.R. 9673. A bill to require the Administrator of the National Oceanic and Atmospheric Administration to establish an assessment program for commercial-scale offshore aquaculture through demonstration projects, to establish Aquaculture Centers of Excellence, to support aquaculture workforce development and working waterfronts, and for other purposes; to the Committee on Natural Resources, and in addition to the Committee on Education and Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. EZELL:

H.R. 9674. A bill to direct the Commandant of the Coast Guard to establish a pilot program to provide corrosion prevention and control assistance to Coast Guard field units, and for other purposes; to the Committee on Transportation and Infrastructure.

By Mr. FOSTER:

H.R. 9675. A bill to authorize the Assistant Secretary for Mental Health and Substance Use, acting through the Director of the Center for Substance Abuse Treatment, to award grants to States to expand access to clinically appropriate services for opioid abuse, dependence, or addiction; to the Committee on Energy and Commerce.

H.R. 9676. A bill to direct the Comptroller General of the United States to evaluate and report on the inpatient and outpatient treatment capacity, availability, and needs of the United States with respect to opioid-use disorders, and for other purposes; to the Committee on Energy and Commerce, and in addition to the Committee on Natural Resources, for a period to be subsequently de-

termined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 9677. A bill to require the Secretary of Housing and Urban Development to establish a program to provide housing assistance to graduate students; to the Committee on Financial Services.

By Mr. GARCÍA of Illinois (for himself and Mr. FITZPATRICK):

H.R. 9678. A bill to amend title 49, United States Code, require employers of airport service workers at small, medium, and large hub airports to ensure that airport service workers are paid the prevailing wage and provided fringe benefits, and for other purposes; to the Committee on Transportation and Infrastructure, and in addition to the Committee on Education and Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

H.R. 9679. A bill to provide a private cause of action for exposure of personally identifiable information of victims or victims' personal or medical files or similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy in releasing documents under the Epstein Files Transparency Act; to the Committee on the Judiciary.

H.R. 9681. A bill to amend the Leahy-Smith America Invents Act to limit intellectual property protection for plants, and for other purposes; to the Committee on the Judiciary.

H.R. 9682.
