MOMENT OF SILENCE HONORING REPRESENTATIVE KAY GRANGER

(Mr. GOLDMAN of Texas asked and was given permission to address the House for 1 minute.)

Mr. GOLDMAN of Texas. Mr. Speaker, on August 2 we lost Kay Granger. All of you knew her. She was a legend in this Chamber. She was a legend in Fort Worth, Texas. She was a legend in Texas. She was a legend in America.

At her funeral a week ago Saturday, her son spoke so eloquently about her. He didn't talk about her accomplishments here. He talked about her being just an ordinary mom, just an ordinary person who happened to do extraordinary things.

She was the first Republican woman mayor of the city of Fort Worth. She was the first Republican woman ever to be elected to Congress from Texas. As many of you know and so many of her fellow appropriators who are up here know, she was the first woman to be chair of the Defense Subcommittee on Appropriations and then the first woman ever in the U.S. Congress to be chair of the Appropriations Committee.

She broke down barriers everywhere she went. When people said, "You can't

do that," she said, "Tell me why. I am going to anyway," as all of you know, especially when she rose to be the Appropriations Committee chair.

She didn't get there because it was easy. She got there because it was tough, and she always took the tough route.

She was an extraordinary woman. Fort Worth has lost a legend. We will never forget her, and we will remember her forever just as every single one of you who served with her will as well.

Mr. Speaker, I yield to the gentleman from Texas (Mr. VEASEY), my Democratic colleague.

Mr. VEASEY. Mr. Speaker, I thank Mr. GOLDMAN for yielding me time.

The ceremony for Kay was absolutely beautiful. I have to let everyone know that. I want to reiterate what CRAIG just talked about. Her son J.D. gave such an amazing testimony about her life.

I want everyone here to know that Kay was a Congresswoman here, and she did remarkable things during her tenure representing Fort Worth. Fort Worth is a better place because of Kay's service in the U.S. House.

But so many people had long-term relationships with Kay Granger. She was a teacher in the Birdville ISD, and people knew her from that. So many people have stories about her time teaching them, people that are still with us today. She was a businesswoman. Kay had a group of diverse friends that she dined with, that she vacationed with, that she did things with. She was someone who was, as I say, a woman before her time really, and she touched so many different people's lives.

When I would go home, people would always ask me: MARC, how do you and Kay get along? I see Democrats and Republicans are always at each other. I would tell people: Kay still is like our mayor. She is still just like the mayor of Fort Worth. We worked great together on things.

Fort Worth will miss her. She was an amazing person to work with, and she always put Fort Worth first when she was here. As the gentleman from Texas (Mr. GOLDMAN) just said, Kay is going to be sorely missed. She was an incredible and remarkable person.

IT IS TIME FOR CONGRESS TO ACT

(Mr. KENNEDY of Utah asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. KENNEDY of Utah. Mr. Speaker, last week Meta reached a \$12.2 billion settlement and agreed to implement new safety guardrails in youth protections.

We have all witnessed the harms caused by an unchecked social media algorithm: anxiety and depression, lost sleep, and even a lost childhood. An entire generation of young people are struggling under the weight of a technology engineered to capture their attention and hold it for as long as possible.

I thank Utah Attorney General Derek Brown for helping to lead us in this fight. This is a landmark win, but its reach is limited. It is one company. It does not cover the next platform. It does not cover the next algorithm. Most importantly, it does not guarantee protection for the next child.

Congress needs to act to implement lasting changes. Congress has a responsibility to set one clear standard that applies to every platform before the harm happens.

That is what my Algorithm Accountability Act does. It strips section 230 immunity from platforms that violate a clear duty of care to their users, and it gives families, not just State attorneys general, the ability to hold these companies accountable in Federal court.

It is time for Congress to act.

MAIL-IN VOTING UNDER ATTACK

BRING EPSTEIN PERPETRATORS TO JUSTICE

(Mr. MASSIE asked and was given permission to address the House for 1 minute.)

Mr. MASSIE. Mr. Speaker, it has been a year since the President signed the Epstein Files Transparency Act, and the government continues to withhold over 3 million files.

That is why we have introduced the Epstein Files Transparency Act II, to bring the fight to the State courts, accountability to the Department of Justice, and closure for survivors.

We want perpetrators of these crimes to be investigated and prosecuted, men like: Jes Staley; Leon Black; Les Wexner; David Copperfield; Lapo Elkann; Tom Pritzker; Glenn Dubin; Frederic Fekkai; Eduardo Teodorani; Jean-Luc Brunel, conveniently dead by suicide in prison; Daniel Siad, recently discovered dead in Paris; Ramsey Elkholy; and Prince Andrew, who committed sex crimes in the United States, too; and women like Leslie Groff, not a victim, who conspired with Epstein to traffic other women.

Perhaps hearing these names will shame the Department of Justice into delivering justice.

REMEMBERING ANTHONY JOSEPH MANTO

(Mr. LATIMER asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. LATIMER. Mr. Speaker, I rise today on the floor of the U.S. House of Representatives to pay tribute to Anthony Joseph Manto, a Rye resident and neighbor whom we lost a few days ago at the age of 83.

Tony was the consummate good guy, and for many years a dedicated family man, married to his wife, Claire, for over 50 years; father to Gina, Anthony, and Chrissy; and grandfather to five grandchildren.

He served at Con Edison for decades, starting from the manhole up to the corporate offices. He coupled family and career with extensive community service, with POTS, Meals on Wheels, Helping Hands, and other groups.

He served his country in the U.S. Army from 1965 to 1967, serving a stint in Vietnam. A Queens native, he graduated from Queens College and made his life in Westchester.

Tony was the life of the party at every party on Adelaide Street, at

Playland, and elsewhere. He was a warm, friendly, well-traveled man, and he was loved by all.

We will miss Tony, and we remember him on this day.

RECOGNIZING INTERNATIONAL OVERDOSE AWARENESS DAY

(Mr. BRESNAHAN asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. BRESNAHAN. Mr. Speaker, I rise to recognize International Overdose Awareness Day.

Today, we remember the hundreds of thousands of Americans who have lost their lives to overdose, and we remember the families, friends, and the communities left behind.

However, these aren't statistics. They are our neighbors, our family members, and our friends. No race, gender, ZIP Code, or family is immune from this epidemic.

International Overdose Awareness Day is a chance to remember those we have lost, stand with those in recovery, and recognize the people on the front lines who are working to save lives.

We have a responsibility to do everything we can to stop these deadly drugs from reaching our communities, hold those who traffic them accountable, and make sure people struggling with addiction can get the help that they need.

Today, we remember those who were taken from this world far too soon, and we recommit ourselves to making sure fewer families experience this kind of pain.

HATE HAS NO PLACE HERE

(Mrs. GRIJALVA asked and was given permission to address the House for 1 minute and to revise and extend her remarks.)

Mrs. GRIJALVA. Mr. Speaker, I rise today to remember the victims of a shooting that occurred outside of the Venture-N bar in Tucson, Arizona, last night—Vincent Siqueiros and Cameron Capara—and to demand that this Chamber take immediate action to ensure that this can never happen again.

I am disgusted by the targeted act of hate and the cold-blooded murder of two members of our LGBTQIA+ community. This horrific attack is a painful reminder that even in welcoming communities like Tucson, hate and violence against our LGBTQIA+ community still exists.

When the hate is combined with easy access to firearms, the consequences can be deadly. I am sick and tired of Congress refusing to lift a finger to protect our communities while every day dozens of people are shot and killed across this country. It does not have to be this way.

The House of Representatives is returning to session this week, and our first action should be passing common-sense gun safety reforms that we know can save lives.
