S. 343

At the request of Mr. VAN HOLLEN, the name of the Senator from Wisconsin (Ms. BALDWIN) was added as a cosponsor of S. 343, a bill to require full funding of part A of title I of the Elementary and Secondary Education Act of 1965 and the Individuals with Disabilities Education Act.

S. 455

At the request of Mr. BLUMENTHAL, the name of the Senator from Connecticut (Mr. MURPHY) was added as a cosponsor of S. 455, a bill to amend section 287 of the Immigration and Nationality Act to limit immigration enforcement actions at sensitive locations, to clarify the powers of immigration officers at sensitive locations, and for other purposes.

S. 478

At the request of Mr. KENNEDY, the names of the Senator from North Dakota (Mr. HOEVEN) and the Senator from Nebraska (Mrs. FISCHER) were added as cosponsors of S. 478, a bill to amend title 38, United States Code, to prohibit the Secretary of Veterans Affairs from transmitting certain information to the Department of Justice for use by the national instant criminal background check system.

S. 986

At the request of Mr. KAINE, the name of the Senator from New Hampshire (Ms. HASSAN) was added as a cosponsor of S. 986, a bill to address and take action to prevent bullying and harassment of students.

S. 1138

At the request of Ms. HASSAN, the names of the Senator from New Mexico (Mr. LUJÁN) and the Senator from Ohio (Mr. HUSTED) were added as cosponsors of S. 1138, a bill to require the Secretary of Homeland Security to enhance capabilities for outbound inspections at the southern land border, and for other purposes.

S. 1289

At the request of Mrs. GILLIBRAND, the names of the Senator from Wisconsin (Ms. BALDWIN), the Senator from Washington (Ms. CANTWELL), the Senator from Nevada (Ms. CORTEZ MASTO) and the Senator from Hawaii (Mr. SCHATZ) were added as cosponsors of S. 1289, a bill to require the Secretary of the Treasury to mint coins in commemoration of the 25th anniversary of the September 11, 2001, terrorist attacks on the United States and to support programs at the National September 11 Memorial and Museum at the World Trade Center.

S. 1500

At the request of Mrs. SHAHEEN, the name of the Senator from Rhode Island (Mr. REED) was added as a cosponsor of S. 1500, a bill to amend title XXVII of the Public Health Service Act to prohibit group health plans and health insurance issuers offering group or individual health insurance coverage from imposing cost-sharing requirements with respect to diagnostic and supplemental breast examinations.

S. 1538

At the request of Mr. BLUMENTHAL, the name of the Senator from Massachusetts (Ms. WARREN) was added as a cosponsor of S. 1538, a bill to amend the Animal Welfare Act to expand and improve the enforcement capabilities of the Attorney General, and for other purposes.

S. 1663

At the request of Mrs. MURRAY, the name of the Senator from Michigan (Mr. PETERS) was added as a cosponsor of S. 1663, a bill to prohibit commercial sexual orientation conversion therapy, and for other purposes.

S. 1715

At the request of Mr. HAGERTY, the names of the Senator from Arkansas (Mr. COTTON), the Senator from Alabama (Mr. TUBERVILLE) and the Senator from Tennessee (Mrs. BLACKBURN) were added as cosponsors of S. 1715, a bill to prohibit payment card networks and covered entities from requiring the use of or assigning merchant category codes that distinguish a firearms retailer from a general merchandise retailer or sporting goods retailer, and for other purposes.

S. 1866

At the request of Ms. BALDWIN, the name of the Senator from Rhode Island (Mr. REED) was added as a cosponsor of S. 1866, a bill to amend the Public Health Service Act to reauthorize and improve the National Breast and Cervical Cancer Early Detection Program for fiscal years 2026 through 2030, and for other purposes.

S. 2006

At the request of Ms. WARREN, the names of the Senator from Connecticut (Mr. BLUMENTHAL), the Senator from New Mexico (Mr. HEINRICH) and the Senator from Delaware (Mr. COONS) were added as cosponsors of S. 2006, a bill to amend title 10, United States Code, to prohibit discrimination in the

Armed Forces on the basis of gender identity, and for other purposes.

S. 2042

At the request of Ms. CANTWELL, the names of the Senator from Rhode Island (Mr. REED) and the Senator from New Jersey (Mr. KIM) were added as cosponsors of S. 2042, a bill to provide lasting protection for inventoried roadless areas within the National Forest System.

S. 2195

At the request of Ms. BALDWIN, the names of the Senator from Wyoming (Mr. BARRASSO) and the Senator from New York (Mrs. GILLIBRAND) were added as cosponsors of S. 2195, a bill to award a Congressional Gold Medal, collectively, to the brave women who served in World War II as members of the U.S. Army Nurse Corps and U.S. Navy Nurse Corps.

S. 2845

At the request of Mr. WYDEN, the name of the Senator from California (Mr. PADILLA) was added as a cosponsor of S. 2845, a bill to amend the Internal Revenue Code of 1986 to eliminate tax loopholes that allow billionaires to defer tax indefinitely through planning strategies such as "buy, borrow, die", to modify over 30 tax provisions so that billionaires are required to pay taxes annually, and for other purposes.

S. 2870

At the request of Mr. CORNYN, the names of the Senator from New Hampshire (Ms. HASSAN) and the Senator from Florida (Mrs. MOODY) were added as cosponsors of S. 2870, a bill to amend the Controlled Substances Act to require regulated persons to identify tableting machines and encapsulating machines by serial number.

S. 3267

At the request of Ms. COLLINS, the name of the Senator from Connecticut (Mr. BLUMENTHAL) was added as a cosponsor of S. 3267, a bill to amend title XVIII of the Social Security Act to provide for Medicare coverage of blood-based dementia screening tests.

S. 3332

At the request of Mr. CORNYN, the name of the Senator from Indiana (Mr. YOUNG) was added as a cosponsor of S. 3332, a bill to amend the Internal Revenue Code of 1986 to increase the exclusion of gain from the sale of a principal residence, and for other purposes.

At the request of Mrs. HYDE-SMITH, the name of the Senator from Pennsylvania (Mr. MCCORMICK) was added as a cosponsor of S. 3916, a bill to prohibit Federal funding of State firearm ownership databases, and for other purposes.

S. 3990

At the request of Ms. SMITH, the names of the Senator from Vermont (Mr. WELCH), the Senator from Maryland (Mr. VAN HOLLEN), the Senator from New Hampshire (Ms. HASSAN), the Senator from Virginia (Mr. WARNER) and the Senator from Arizona (Mr. KELLY) were added as cosponsors of S. 3990, a bill to increase access to pre-exposure prophylaxis to reduce the transmission of HIV.

S. 4134

At the request of Mr. RICKETTS, the name of the Senator from Florida (Mr. SCOTT) was added as a cosponsor of S. 4134, a bill to amend chapter 131 of title 5, United States Code, to require certain restrictions on stocks for Members of Congress and their spouses and dependents, and for other purposes.

S. 4154

At the request of Mr. WICKER, the name of the Senator from Georgia (Mr. WARNOCK) was added as a cosponsor of S. 4154, a bill to establish a task force to address legal and ethical issues related to the use of AI speech-to-text technology and automatic speech recognition technology in the United States judicial system, and for other purposes.

S. 4176

At the request of Mrs. MOODY, the name of the Senator from Arkansas (Mr. COTTON) was added as a cosponsor of S. 4176, a bill to amend title XIX of the Social Security Act to direct State Medicaid fraud control units to investigate and prosecute instances of beneficiary fraud.

S. 4281

At the request of Mr. RICKETTS, the names of the Senator from Alabama (Mrs. BRITT) and the Senator from Hawaii (Mr. SCHATZ) were added as cosponsors of S. 4281, a bill to provide for export restrictions on certain semiconductor manufacturing equipment and components therefor, and for other purposes.

S. 4283

At the request of Ms. BALDWIN, the names of the Senator from New York (Mrs. GILLIBRAND) and the Senator from Minnesota (Ms. KLOBUCHAR) were added as cosponsors of S. 4283, a bill to amend the Public Health Service Act to reauthorize a public health and bio-preparedness workforce loan repayment program.

S. 4349

At the request of Mr. MORAN, the name of the Senator from Vermont

(Mr. WELCH) was added as a cosponsor of S. 4349, a bill to ensure responsible age assurance practices within the mobile ecosystem, particularly concerning the protection of minors, and for other purposes.

S. 4387

At the request of Mrs. SHAHEEN, the names of the Senator from Minnesota (Ms. SMITH) and the Senator from Illinois (Ms. DUCKWORTH) were added as cosponsors of S. 4387, a bill to study the extent to which individuals are more at risk of maternal morbidity or mortality as a result of being a victim of intimate partner violence.

S. 4413

At the request of Mr. SANDERS, the names of the Senator from Michigan (Ms. SLOTKIN) and the Senator from Minnesota (Ms. SMITH) were added as cosponsors of S. 4413, a bill to amend the Occupational Safety and Health Act of 1970 to expand coverage under the Act, to increase protections for whistleblowers, to increase penalties for high gravity violations, to adjust penalties for inflation, to provide rights for victims or their family members, and for other purposes.

S. 4429

At the request of Mr. MORENO, the names of the Senator from Oregon (Mr. MERKLEY), the Senator from Delaware (Mr. COONS) and the Senator from Connecticut (Mr. BLUMENTHAL) were added as cosponsors of S. 4429, a bill to prohibit the importation, manufacture, sale, resale, or introduction into interstate commerce in the United States of connected vehicles and related software and hardware associated with foreign adversaries.

S. 4504

At the request of Mr. VAN HOLLEN, the name of the Senator from Oregon (Mr. WYDEN) was added as a cosponsor of S. 4504, a bill to improve the full-service community school program, and for other purposes.

S. 4576

4671, a bill to amend chapter 44 of title 18, United States Code, to enhance penalties for theft of a firearm from a Federal firearms licensee.

At the request of Mr. CORNYN, the name of the Senator from Alabama (Mr. TUBERVILLE) was added as a cosponsor of S. 4775, a bill to amend the Protection of Lawful Commerce in Arms Act to clarify liability protections for firearms and associated manufacturers and retailers, and for other purposes.

S. 4796

At the request of Mr. SCHUMER, the name of the Senator from Wisconsin (Ms. BALDWIN) was added as a cosponsor of S. 4796, a bill to amend the Internal Revenue Code of 1986 to increase the rate of the excise tax on the repurchase of corporate stock, and for other purposes.

S. 4814

At the request of Mr. MARKEY, the names of the Senator from Michigan (Ms. SLOTKIN) and the Senator from New Hampshire (Mrs. SHAHEEN) were added as cosponsors of S. 4814, a bill to require the Secretary of Homeland Security to designate Haiti for temporary protected status.

S. 4944

At the request of Mr. ARMSTRONG, the names of the Senator from Tennessee (Mr. HAGERTY) and the Senator from North Carolina (Mr. TILLIS) were added as cosponsors of S. 4944, a bill to streamline permitting under the Natural Gas Act, the Federal Water Pollution Control Act, and the National Environmental Policy Act of 1969, and for other purposes.

S. 5004

At the request of Ms. SMITH, the names of the Senator from Connecticut (Mr. BLUMENTHAL) and the Senator from Oregon (Mr. MERKLEY) were added as cosponsors of S. 5004, a bill to amend the Employee Retirement Income Security Act of 1974 to require a group health plan (or health insurance coverage offered in connection with such a plan) to provide for cost-sharing for oral anticancer drugs on terms no less favorable than the cost-sharing provided for anticancer medications administered by a health care provider.

S. 5028

At the request of Mr. HUSTED, the name of the Senator from Alabama (Mr. TUBERVILLE) was added as a cosponsor of S. 5028, a bill to amend the Public Utility Regulatory Policies Act

of 1978 to establish a Federal standard relating to the recovery of the full, incremental costs of upgrades that serve large-load customers, and for other purposes.

S. 5075

At the request of Mr. WHITEHOUSE, the name of the Senator from Rhode Island (Mr. REED) was added as a cosponsor of S. 5075, a bill to amend the Federal Election Campaign Act of 1971 to apply the ban on contributions and expenditures by foreign nationals under such Act to foreign-controlled, foreign-influenced, and foreign-owned domestic business entities, and for other purposes.

S. 5164

At the request of Mr. MORAN, the name of the Senator from New Mexico (Mr. HEINRICH) was added as a cosponsor of S. 5164, a bill to amend titles XVIII and XIX of the Social Security Act to make improvements relating to the designation of rural emergency hospitals.

S. 5179

At the request of Mrs. BLACKBURN, the name of the Senator from Florida (Mrs. MOODY) was added as a cosponsor of S. 5179, a bill to clarify that for purposes of Federal nondiscrimination requirements applicable to education programs or activities receiving Federal financial assistance, discrimination prohibited under title IX of the Education Amendments of 1972 is based on the biological reality of sex.

S. 5194

At the request of Mr. DURBIN, the name of the Senator from Delaware (Mr. COONS) was added as a cosponsor of S. 5194, a bill to amend title 28, United States Code, to improve the maintenance, alteration, and construction of United States courthouses, and for other purposes.

S. 5200

At the request of Mr. FETTERMAN, the name of the Senator from California (Mr. PADILLA) was added as a cosponsor of S. 5200, a bill to amend the Food, Agriculture, Conservation, and Trade Act of 1990 to include spotted lanternfly control research and development as a high-priority research and extension initiative, and for other purposes.

S. 5250

At the request of Ms. COLLINS, the name of the Senator from Tennessee (Mrs. BLACKBURN) was added as a cosponsor of S. 5250, a bill to amend title XVIII of the Social Security Act to decrease fraud related to home health agencies in Medicare, and for other purposes.

S. 5255

At the request of Mr. LANKFORD, the name of the Senator from Tennessee (Mrs. BLACKBURN) was added as a cosponsor of S. 5255, a bill to amend title 10, United States Code, to define the purpose, role, duties, and professional qualification requirements for chaplains in the Armed Forces, and for other purposes.

S. 5263

At the request of Mr. MCCORMICK, the name of the Senator from New Hampshire (Ms. HASSAN) was added as a cosponsor of S. 5263, a bill to amend the Workforce Innovation and Opportunity Act to provide to States and local areas information on the best practices for addressing the effects that substance use disorder has on the workforce, and to provide local areas with grants to provide training activities related to the treatment and prevention of substance use disorder.

S. 5321

At the request of Mr. LUJÁN, the name of the Senator from California (Mr. SCHIFF) was added as a cosponsor of S. 5321, a bill to amend title XIX of the Social Security Act to require coverage of, and expand access to, home and community-based services under the Medicaid program, to award grants for the creation, recruitment, training and education, retention, and advancement of the direct care workforce and to award grants to support family caregivers, and for other purposes.

S. 5371

At the request of Mr. LEE, the name of the Senator from Arkansas (Mr. COTTON) was added as a cosponsor of S. 5371, a bill to close loopholes in the immigration laws that serve as incentives to aliens to attempt to enter the United States unlawfully, and for other purposes.

S.J. RES. 161

At the request of Mr. KELLY, the name of the Senator from Massachusetts (Mr. MARKEY) was withdrawn as a cosponsor of S.J. Res. 161, a joint resolution to direct the removal of United States Armed Forces from hostilities within or against the Islamic Republic of Iran that have not been authorized by Congress.

At the request of Mr. KELLY, the name of the Senator from Oregon (Mr. MERKLEY) was added as a cosponsor of S.J. Res. 161, *supra*.

S.J. RES. 205

At the request of Ms. LUMMIS, the names of the Senator from Oklahoma (Mr. LANKFORD) and the Senator from Alaska (Mr. SULLIVAN) were added as cosponsors of S.J. S.J. RES. 208

At the request of Mr. HUSTED, the name of the Senator from Oklahoma (Mr. LANKFORD) was added as a cosponsor of S.J. Res. 208, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Environmental Protection Agency relating to "California State Motor Vehicle Pollution Control Standards; Advanced Clean Car Program; Reconsideration of a Previous Withdrawal of a Waiver of Preemption; Notice of Decision".

S. CON. RES. 6

STATEMENTS ON INTRODUCED BILLS AND JOINT RESOLUTIONS

S. 5390. A bill to terminate and refund certain duties imposed by the President, and for other purposes; to the Committee on Finance.

Mr. SCHUMER. Mr. President, I ask unanimous consent that the text of the bill be printed in the RECORD.

There being no objection, the text of the bill was ordered to be printed in the RECORD, as follows:

S. 5390

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the "End Trump's Tariff Tax Act".

SEC. 2. TERMINATION OF DUTIES IMPOSED PURSUANT TO FORCED LABOR IMPORT PROHIBITION INVESTIGATION.

(a) IN GENERAL.—Notwithstanding any other provision of law, no duties imposed before, on, or after the date of the enactment of this Act pursuant to the investigations described in subsection (b) shall have any force or effect on or after that date.
