S. Res. 574. A resolution observing the fifth anniversary of the attack on the United States Capitol on January 6, 2021, and recognizing the essential work of United States Capitol personnel, including the United States Capitol Police; to the Committee on Rules and Administration.

By Mr. LANKFORD (for himself and Mr. MULLIN):

S. Res. 575. A resolution congratulating the Oklahoma State University men's cross country team for winning the 2025 National Collegiate Athletic Association Men's Division I Cross Country National Championship; considered and agreed to.

ADDITIONAL COSPONSORS

S. 128

At the request of Mr. LEE, the name of the Senator from Montana (Mr. SHEEHY) was added as a cosponsor of S. 128, a bill to amend the National Voter Registration Act of 1993 to require proof of United States citizenship to register an individual to vote in elections for Federal office, and for other purposes.

S. 858

At the request of Mr. JUSTICE, the name of the Senator from Texas (Mr. CORNYN) was added as a cosponsor of S. 858, a bill to authorize the National Medal of Honor Museum Foundation to establish a commemorative work on the National Mall to honor the extraordinary acts of valor, selfless service, and sacrifice displayed by Medal of Honor recipients.

S. 1335

At the request of Mr. TILLIS, the name of the Senator from Indiana (Mr. YOUNG) was added as a cosponsor of S. 1335, a bill to amend the Internal Revenue Code of 1986 to exclude debt held by certain insurance companies from capital assets and to extend capital loss carryovers for such companies from 5 years to 10 years.

S. 1650

At the request of Ms. DUCKWORTH, the name of the Senator from Massachusetts (Mr. MARKEY) was added as a cosponsor of S. 1650, a bill to amend title 38, United States Code, to modify authorities relating to the collective bargaining of employees in the Veterans Health Administration.

S. 1707

At the request of Mr. CASSIDY, the name of the Senator from Maine (Ms. COLLINS) was added as a cosponsor of S. 1707, a bill to amend the Employee Retirement Income Security Act of 1974 and the Internal Revenue Code of 1986 with respect to minimum participation standards for pension plans and qualified trusts.

S. 1831

At the request of Mr. KAINE, the name of the Senator from Maine (Ms. COLLINS) was added as a cosponsor of S. 1831, a bill to amend the Internal Revenue Code of 1986 and the Employee Retirement Income Security Act of 1974 to allow for periodic automatic reenrollment under qualified automatic contribution arrangements, and for other purposes.

S. 1935

At the request of Ms. ROSEN, the name of the Senator from Minnesota (Ms. KLOBUCHAR) was added as a cosponsor of S. 1935, a bill to amend title XI of the Social Security Act to provide for the testing of a community-based palliative care model.

S. 1945

At the request of Mr. JUSTICE, the name of the Senator from Pennsylvania (Mr. MCCORMICK) was added as a cosponsor of S. 1945, a bill to prohibit States and local governments from prohibiting or limiting the connection, reconnection, modification, installation, transportation, distribution, or expansion of an energy service based on the type or source of energy to be delivered, and for other purposes.

S. 2019

At the request of Mr. CRAPO, the name of the Senator from Minnesota (Ms. KLOBUCHAR) was added as a cosponsor of S. 2019, a bill to establish a Task Force for Recognizing and Averting Payment Scams, and for other purposes.

S. 2521

At the request of Ms. ROSEN, the name of the Senator from Minnesota (Ms. KLOBUCHAR) was added as a cosponsor of S. 2521, a bill to allow participants in the National Health Service Corps to defer their obligated service in order to receive training in palliative care services.

S. 2761

At the request of Mr. TILLIS, the name of the Senator from Kansas (Mr. MARSHALL) was added as a cosponsor of S. 2761, a bill to amend title XVIII of the Social Security Act to provide long-term stability for Medicare beneficiary access to clinical diagnostic laboratory tests by improving the accuracy of, and feasibility of data collection for, the private payor-based fee schedule payment rates applied under the Medicare program for such tests, and for other purposes.

S. 2870

At the request of Mr. CORNYN, the names of the Senator from West Virginia (Mrs. CAPITO) and the Senator

from Nevada (Ms. CORTEZ MASTO) were added as cosponsors of S. 2870, a bill to amend the Controlled Substances Act to require regulated persons to identify tableting machines and encapsulating machines by serial number.

S. 3048

At the request of Ms. MURKOWSKI, the name of the Senator from Georgia (Mr. OSSOFF) was added as a cosponsor of S. 3048, a bill to amend the Controlled Substances Act to allow for the use of telehealth in substance use disorder treatment, and for other purposes.

S. 3101

At the request of Mr. SCOTT of Florida, the name of the Senator from Alaska (Mr. SULLIVAN) was added as a cosponsor of S. 3101, a bill to prevent citizens of foreign adversarial nations from entering into or enforcing surrogacy contracts in the United States.

S. 3229

At the request of Ms. ROSEN, the name of the Senator from New Mexico (Mr. HEINRICH) was added as a cosponsor of S. 3229, a bill to limit the authority of the President to impose duties on articles of food.

S. 3257

At the request of Mr. HOEVEN, the names of the Senator from Alaska (Mr. SULLIVAN) and the Senator from Wisconsin (Ms. BALDWIN) were added as cosponsors of S. 3257, a bill to require the Administrator of the Federal Aviation Administration to revise regulations for certain individuals carrying out aviation activities who disclose a mental health diagnosis or condition, and for other purposes.

S. 3259

At the request of Ms. ERNST, the name of the Senator from Wyoming (Ms. LUMMIS) was added as a cosponsor of S. 3259, a bill to amend the Infrastructure Investment and Jobs Act to require remaining funds under the Broadband Equity, Access, and Deployment Program to be used for deficit reduction.

S. 3322

At the request of Ms. CORTEZ MASTO, the name of the Senator from Arizona (Mr. GALLEGOS) was added as a cosponsor of S. 3322, a bill to amend or repeal certain provisions of Public Law 119-21 that undermine protections and heighten dangers for unaccompanied alien children, and for other purposes.

S. 3335

At the request of Mr. HOEVEN, the name of the Senator from Pennsylvania (Mr. MCCORMICK) was added as a cosponsor of S. 3335, a bill to reestablish the National Coal Council in the Department of Energy to provide advice and recommendations to the Secretary of Energy on matters relating to coal and the coal industry, and for other purposes.

S. 3376

At the request of Mrs. BLACKBURN, the name of the Senator from South Carolina (Mr. SCOTT) was added as a cosponsor of S. 3376, a bill to require the

Administrator of the Transportation Security Administration to establish a pilot project to evaluate the effectiveness of technologies to combat cargo theft, and for other purposes.

S. 3456

At the request of Mr. SHEEHY, the name of the Senator from New Jersey (Mr. KIM) was added as a cosponsor of S. 3456, a bill to amend the Federal Lands Recreation Enhancement Act to provide for a free annual National Parks and Federal Recreational Lands Pass for law enforcement officers and firefighters.

S. 3492

At the request of Mr. BLUMENTHAL, the names of the Senator from New York (Mrs. GILLIBRAND), the Senator from Montana (Mr. DAINES), the Senator from North Carolina (Mr. TILLIS) and the Senator from Maryland (Ms. ALSOBROOKS) were added as cosponsors of S. 3492, a bill to amend titles XVIII and XIX of the Social Security Act to require skilled nursing facilities, nursing facilities, intermediate care facilities for the intellectually disabled, and inpatient rehabilitation facilities to permit essential caregivers access during any period in which regular visitation is restricted.

S.J. RES. 98

At the request of Mr. KAINE, the names of the Senator from Hawaii (Mr. SCHATZ), the Senator from Vermont (Mr. WELCH), the Senator from Illinois (Ms. DUCKWORTH), the Senator from Maryland (Mr. VAN HOLLEN), the Senator from Connecticut (Mr. BLUMENTHAL), the Senator from Vermont (Mr. SANDERS), the Senator from Colorado (Mr. BENNET), the Senator from Oregon (Mr. WYDEN), the Senator from Nevada (Ms. ROSEN), the Senator from Massachusetts (Mr. MARKEY), the Senator from Hawaii (Ms. HIRONO), the Senator from Connecticut (Mr. MURPHY), the Senator from Maryland (Ms. ALSOBROOKS), the Senator from New Jersey (Mr. BOOKER) and the Senator from New York (Mrs. GILLIBRAND) were added as cosponsors of S.J. Res. 98, a joint resolution to direct the removal of United States Armed Forces from hostilities within or against Venezuela that have not been authorized by Congress.

SENATE RESOLUTION 574—OBSERVING THE FIFTH ANNIVERSARY OF THE ATTACK ON THE UNITED STATES CAPITOL ON JANUARY 6, 2021, AND RECOGNIZING THE ESSENTIAL WORK OF UNITED STATES CAPITOL PERSONNEL, INCLUDING THE UNITED STATES CAPITOL POLICE

Mr. PADILLA (for himself, Mr. SCHUMER, Mr. WHITEHOUSE, Mr. PETERS, Mr. DURBIN, Mr. SCHIFF, Mrs. GILLIBRAND, Mr. HEINRICH, Ms. DUCKWORTH, Ms. SMITH, Mr. REED, Ms. ALSOBROOKS, Mr.

FETTERMAN, Mr. KING, Mr. KIM, Mr. BOOKER, Mr. MERKLEY, Mr. SCHATZ, Ms. BALDWIN, Mrs. MURRAY, Ms. CORTEZ MASTO, Ms. KLOBUCHAR, Mr. MARKEY, Mr. COONS, Mr. SANDERS, Mr. BLUMENTHAL, Mr. VAN HOLLEN, Ms. HIRONO, Mr. WELCH, Mrs. SHAHEEN, Ms. HASSAN, Mr. KAINE, Ms. CANTWELL, Mr. MURPHY, Ms. BLUNT ROCHESTER, and Ms. MURKOWSKI) submitted the following resolution; which was referred to the Committee on Rules and Administration:

S. RES. 574

Whereas, on January 6, 2021, violent insurrectionists, carrying Confederate flags and symbols, ransacked the Capitol, destroying property and vandalizing the building in an attempt to disrupt a joint session of Congress to count the electoral ballots and certify the results of the 2020 presidential election;

Whereas, for nearly 5 hours, those violent attackers used bear spray, flag poles, fire extinguishers, pipes, bats, bricks, and other items to assault law enforcement officers from the United States Capitol Police, the Metropolitan Police Department, and other law enforcement agencies who bravely defended the Capitol that day;

Whereas more than 100 law enforcement officers were injured defending the Capitol, including sustaining traumatic brain injuries, cracked ribs, smashed spinal discs, and stabbings, and the events of that day contributed to the deaths of 5 officers who later passed away;

Whereas, in the days following the January 6 attack, the Senate unanimously passed and Congress rightly awarded Congressional Gold Medals to the United States Capitol Police and the Metropolitan Police Department, recognizing the many officers who deserve the deep gratitude of the United States for putting their lives on the line to protect the Capitol and the democratic process of the United States;

Whereas Congress passed the Consolidated Appropriations Act of 2022 (Public Law 117-103), which was signed into law on March 15, 2022, directing that a plaque be placed on the western front of the United States Capitol to honor the United States Capitol Police and other law enforcement officers who responded on January 6, 2021, yet nearly 4 years after passage, the Speaker of the House has failed to comply with that law and allow the completed plaque to be installed;

Whereas Capitol custodial, janitorial, and maintenance staff were there to pick up the pieces and deserve the distinct honor and gratitude of the United States, as they also put their lives on the line serving the United States on January 6, 2021;

Whereas the work of United States Capitol personnel, including the United States Capitol Police and Capitol custodial, janitorial, and maintenance staff, allowed Members of the Senate to return to the Senate Chamber to continue its constitutional duty to certify the electoral votes and secure the democracy of the United States;

Whereas the United States Capitol Police officers and Capitol custodial, janitorial, and maintenance staff and other essential workers, including food services staff, come to work each day and do their jobs with skill, dedication, and dignity; and

Whereas the work of the Capitol Police and Capitol personnel is too often overlooked, but remains essential to the functioning of the Federal Government: Now, therefore, be it

Resolved, That the Senate—

(1) expresses gratitude for the United States Capitol Police, the Metropolitan Po-

lice Department, personnel of the United States Capitol, and all the responding law enforcement officers for their bravery and service to the United States;

(2) recognizes the strength and commitment of the personnel of the United States Capitol who bring skill and dedication to their work every day and who worked through the night on January 6, 2021, and in the days following, to restore dignity to the United States Capitol and to ensure the democracy of the United States continues to function; and

(3) reaffirms its commitment to protect against efforts to undermine democracy and to uphold and defend the Constitution of the United States, including defending the legislative branch.

SENATE RESOLUTION 575—CONGRATULATING THE OKLAHOMA STATE UNIVERSITY MEN'S CROSS COUNTRY TEAM FOR WINNING THE 2025 NATIONAL COLLEGIATE ATHLETIC ASSOCIATION MEN'S DIVISION I CROSS COUNTRY NATIONAL CHAMPIONSHIP

Mr. LANKFORD (for himself and Mr. MULLIN) submitted the following resolution; which was considered and agreed to:

S. RES. 575

Whereas the 2025 Oklahoma State University men's cross country team (referred to in this preamble as the "Cowboys"), under the leadership of head coach Dave Smith, won the team's sixth National Collegiate Athletic Association (referred to in this preamble as "NCAA") Division I championship title;

Whereas the Cowboys won the national men's cross country title for the second time in the last three years, making it the Oklahoma State University's 55th NCAA team championship overall;

Whereas the Cowboys competed in the 2025 NCAA Midwest Regional Championship 10,000-meter race, where they finished first in points, earning an automatic bid to compete for the national title;

Whereas the Cowboys finished the season by winning the Big 12 Cross Country Championship, NCAA Midwest Regional Championship, and the NCAA Division I Cross Country National Championship;

Whereas the Cowboys 24-man cross country team is comprised of talented distance athletes;

Whereas Adisu Guadie, Ryan Schoppe, Will Muirhead, Laban Kipkemboi, Brian Musau, Fouad Messaoudi, and Denis Kipnetich all played a key role in securing the Cowboys a sixth national title;

Whereas Brian Musau was the first of three Cowboys to cross the finish line in the top 10, finishing fourth and beating his previous 10,000 meter record by three seconds, and earned his third cross country All-America honor;

Whereas Fouad Messaoudi and Denis Kipnetich followed suit with fifth and sixth-place finishes, and both Cowboys earned their third cross country All-America honors;

Whereas Adisu Guadie and Ryan Schoppe both earned their first All-American honors; and

Whereas head coach Dave Smith was named Men's National Coach of the Year by the U.S. Track & Field and Cross Country Coaches Association: Now, therefore, be it

Resolved, That the Senate—

(1) congratulates the 2025 Oklahoma State University men's cross country team on its championship season; and
