At the request of Mr. CORNYN, the names of the Senator from Mississippi (Mrs. HYDE-SMITH) and the Senator from Maine (Mr. KING) were added as cosponsors of S. 2870, a bill to amend the Controlled Substances Act to require regulated persons to identify tabletting machines and encapsulating machines by serial number.

S. 2903

At the request of Ms. MURKOWSKI, the name of the Senator from Maine (Ms. COLLINS) was added as a cosponsor of S. 2903, a bill to amend the Employee Retirement Income Security Act of 1974 to require a group health plan or health insurance coverage offered in connection with such a plan to provide an exceptions process for any medication step therapy protocol, and for other purposes.
