|               | On July 22, 2004, by Executive Order 13348, I declared a national emergency<br>and ordered related measures, including the blocking of the property of<br>certain persons connected to the former Liberian regime of Charles Taylor,<br>pursuant to the International Emergency Economic Powers Act (50 U.S.C.<br>1701–1706). I took this action to deal with the unusual and extraordinary<br>threat to the foreign policy of the United States constituted by the actions<br>and policies of former Liberian President Charles Taylor and other persons,<br>in particular their unlawful depletion of Liberian resources and their removal<br>from Liberia and secreting of Liberian funds and property, which have<br>undermined Liberia's transition to democracy and the orderly development<br>of its political, administrative, and economic institutions and resources.<br>I further noted that the Comprehensive Peace Agreement signed on August<br>18, 2003, and the related cease-fire had not yet been universally implemented<br>throughout Liberia, and that the illicit trade in round logs and timber products<br>was linked to the proliferation of and trafficking in illegal arms, which<br>perpetuated the Liberian conflict and fueled and exacerbated other conflicts<br>throughout West Africa. |
|               | The actions and policies of Charles Taylor and others have left a legacy<br>of destruction that continues to undermine Liberia's transformation and<br>recovery. Because the actions and policies of these persons continue to<br>pose an unusual and extraordinary threat to the foreign policy of the United<br>States, the national emergency declared on July 22, 2004, and the measures<br>adopted on that date to deal with that emergency, must continue in effect<br>beyond July 22, 2008. Therefore, in accordance with section 202(d) of the<br>National Emergencies Act (50 U.S.C. 1622(d)), I am continuing for 1 year<br>the national emergency declared in Executive Order 13348.                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                                         |
